1. Rules and Changes: These pre-determined rules will remain unchanged and in effect unless otherwise notified at final check-in during registration. Interpretation of these rules will be at the discretion of tournament director and rules committee. The interpretation of the rules by the tournament director and rules committee will be final.
2. Participation and Eligibility: It is the contestant's responsibility for knowing and abiding by all local, state/provincial and federal regulations pertaining to tournament waters.
3. Fish and Fishing: All state/provincial fishing regulations and rules will be observed, unless the tournament director specifies more stringent regulations. Any fish mauled, frozen, injected with water or other fluid to add weight, white gill, soft flesh, sunken eyes or gills that don't bleed may result in disqualification from the tournament at the discretion of the tournament director and rules committee. Under-sized fish will result in disqualification from the tournament at the discretion of the tournament director and rules committee. Only five (5) fish or less can be officially weighed per entrant (boat). The weight determined by the tournament director and weigh master is the official weight and is not subject to challenge.
4. Spirit of the Rule: All rules have "loop holes". It is the intention of the tournament director and the rules committee to provide a sportsmanlike tournament. All questions and/or problems are to be referred to the tournament director and rules committee who have sole decision-making responsibility on determining the application of the rules. Any disqualification will result in the loss of participation, anglers will not receive a refund.
5. Waivers and Hold Harmless: All contestants in signing an entry form agree to hold harmless any and all promoters, tournament directors, sponsors and organizers. Furthermore, all contestants agree to waiver any and all responsibility for death, injury, damages, liability, theft, fire or loss of any kind.

Unsigned waiver of liability forms will not be accepted for participation in the Michigan Moose Association, 2023 Walleye Tournament.
